## TERMS AND CONDITIONS

#### WILDERNESS PLAYGROUP FEES

Wilderness Playgroup fees are payable before the commencement of term. Playgroup is run during term time only; therefore, fees are dependent on the number of weeks the service is run per term. No refunds are given for missed sessions.

No Trial Fee is charged to join the Wilderness Playgroup. Casual attendance does NOT apply to playgroup Friday. This can be paid by EFTPOS on the day, NO cash payments. To book, please call (08)9387 5055 or email ELC@boldpark.com.

#### NOTICE OF WITHDRAWAL WILDERNESS PLAYGROUP

Written notice of four (4) weeks is required if a decision is made to withdraw from the Wilderness playgroup. Please note that term fees will not be refunded.

#### CANCELLATION

48 hours cancellation required for non-attendance of casual session or fees will be charged.

#### EARLY LEARNING CENTRE FEE SCHEDULE

All families who are eligible for Child Care Subsidy (CCS) need to apply through Services Australia directly to receive a rebate on these fees. Please note, our Trial Fee is charged exclusive to the CCS and must be paid at the time of application.

#### APPLICATION FEE

An Application Fee of \$300 (GST free) must accompany all applications for admissions into Pre-Kindergarten and Kindergarten. This fee covers administration costs and is non-refundable.

#### PAYMENT METHODS

Payment should be made by the due date by one of the following methods: Payment by direct debit through OWSA are deducted fortnightly. Failed payments will incur an additional charge of \$2.50 per transaction.

#### HOLIDAY CARE SERVICE

For Pre-Kindy, Kindy, PP to Year 6 students in April, July, October and December/January (excluding 4 weeks over Christmas/ New Years).

## TERMS AND CONDITIONS

### TRIAL FEE

A Trial Fee of \$300 must accompany all enrolments from Pre-Primary to Year 12. This fee covers administration costs, is non-refundable and does not guarantee a place.

### ENDOWMENT FEE

A non-refundable Endowment Fee is payable on acceptance of a place in Bold Park Community School from Year 1 to Year 12. Endowment fees do not apply for enrolments in Pre-Kindergarten, Kindergarten or Pre-Primary. The endowment fee is due and payable by the start of Term 4 if your child is currently in Pre-Primary.

### TUITION PAYMENT OPTIONS 2026

Consists of tuition fees, infrastructure levy and resource levy. Annual fees can be paid in quarterly, monthly or fortnightly instalments between February and October via the Direct Debit Payment Platform via Parent Lounge. An annual statement will be emailed late-January, which will provide the amounts payable for your 2026 school fees. Based on your direct debit frequency selection, you will be provided a login to the TASS Parents Lounge to pay your tuition fees using the following payment options:

- Annual is one payment paid on or before 14 February 2026.
- Weekly, fortnightly, monthly or quarterly
- Edstart is an alternative payment option for years Pre-Primary to Year 12 where payments can be extended over a longer period. Visit [edstart.com.au/boldpark](http://edstart.com.au/boldpark) for more information.

### PAYMENT OF FEES AND OUTSTANDING ACCOUNTS

In accordance with the BPCS School Fee Policy

- All debt collection fees will be added to the family school fee account to cover this cost for all accounts that are not paid within the guidelines outlined within this Fee Schedule and the BPCS School Fee Policy.
- No refunds will be made for term fees if a student leaves or changes programs at any time during a term i.e. fees are payable for the full term regardless of attendance.

### FINANCIAL HARDSHIP

Many families experience a period of financial hardship sometime during the schooling of their child/ren. Although our ability to help is limited, we would value the opportunity to work with you through such a situation. ### DISHONOUR FEES

The school will charge a dishonour fee for returned direct debits of \$15 per dishonour and pass on any fees charged by the bank. If a cheque is dishonoured, you will be charged the above amount to your fee account.

### SECONDARY ASSISTANCE SCHEME

A means tested assistance scheme administered by the Department of Education may be available to parents who hold eligible concession cards. It comprises an education program allowance and a clothing allowance. Applications must be submitted to the Department of Education in the first term of each year that the parents are eligible. Application forms are available from the school by contacting the Business Manager [business@boldpark.com](mailto:business@boldpark.com)

### INFRASTRUCTURE LEVY

The BPCS Infrastructure Levy assists the school in meeting the lease of the site and maintenance of the buildings and grounds. This is compulsory and non-tax deductible.

### RESOURCES LEVY AND IT LEVY

Additional targeted resources may be required in Middle School and College (For example: iPad, BYO Device and Apps). Please note this fee will not be pro-rated for new enrolments during the year.

The IT Levy covers the provision and management of a school-issued iPad, including:

- Device purchase and standard protective case
- Setup and configuration
- Required educational apps and licenses
- Ongoing maintenance and technical support
- Warranty and repair management

### COLLEGE FEES

For students electing to pursue additional WACE/VET courses, these fees will be in addition to the BPCS Tuition Fees. The fees for students at BPCS cover the holistic program and all aspects of a rich school environment, we cannot offer a discount for students who choose to withdraw from individual WACE, Certificate or other programs offered.

### ANNUAL FEES

Updated fees for the following year are released in November/ December each year. Copies are available to enrolled families or upon request. BPCS reserves the right to change educational programs in line with the school community's needs and cannot refund trial fees when programs change.

### OTHER CHARGES

Incidental costs through the year such as excursions and camps will be charged at the time.

1.32% fee is charged for all BPCS Visa and Mastercard transactions and 1.85% fee is charged for AMEX this may change based on fees charged to BPCS by the bank.

### WITHDRAWALS

A full term's notice in writing must be given to the school before withdrawal. In the event of the intended withdrawal of a student at the end of a year, written notice must be given to the principal prior to the end of Term 3. Failure to provide necessary notice will attract a notice of withdrawal fee of 10% of the student's current annual tuition and infrastructure fees.
